ADMISSIONS REQUIREMENTS FOR A POLICE OFFICER

Police officer shall be a citizen of the Slovak Republic older than 18 years of age who applies in writing, and

- has no criminal record,
- is reliable,
- meets the qualifications requirements stipulated for the position they are to be designated or appointed,
- is physically and mentally fit for the service,
- has a command of the official language,
- has a permanent residence in the territory of the Slovak Republic,
- is not, as per the date of joining the state service, a member of any political party or political movement,

• is fully legally competent, as per the date of joining the state service they shall terminate any and all activities banned pursuant to Section 48 article 6 and 7 Act No. 73/1998 Collection of Acts on state service of police officers, members of the Slovak Intelligence Service, Prison and Court Guard Service of the Slovak Republic and Railway Police as amended.

ENTRANCE EXAM

PART I entrance exam (interview on police state service, physical fitness test, official language proficiency test, psychological exam): as of January 13th, 2025

Upon the entrance exam date an applicant invited must bring their **invitation** and **ID card** and **MUST** submit:

- application for joining the Police Force,
- handwritten CV for police psychologists,
- photocopy of ID card,
- photocopy of health insurance card,
- photocopy of Marriage Certificate (if applicable).

PART II entrance exam (general knowledge test): 06/2025

In compliance with the needs of the Police Force, an applicant may be admitted to studies based upon application and fulfilling the following requirements:

- a) be a citizen of the Slovak Republic;
- b) succeed in admissions procedure to a police state service,
- c) receive sufficient marks in a written general knowledge test within the secondary school curriculum.
- d) pay the fee of €49 to cover the costs of admissions procedure.

SECURITY SERVICES IN PUBLIC ADMINISTRATION

In case the civilian applicant is admitted to studies at the Academy of the Police Force in Bratislava, prior to their enrolment they must submit their extract of the Criminal Registry records not older than 3 months. If the applicant has a criminal record of committing an intentional crime, they shall not be enrolled.

ENTRANCE EXAM (general knowledge test): 06/2025

In compliance with requirements approved by Ministry of Interior of the Slovak Republic, an applicant may be admitted to studies under the following conditions:

- 1) Applicants from EU member states and applicants from third countries are subject to the same admissions criteria as applicants from the Slovak Republic. Foreigners may be admitted to studies under the condition they prove a minimum of B2 proficiency in Slovak language; this shall not apply to citizens of the Czech Republic and foreigners with a secondary school-leaving certificate in Slovak language. Prior to their enrolment foreigners from third countries have to submit a temporary or permanent residence permit under Act No. 404/2011 Collection of Acts on residence of foreigners in compliance with the procedure of the Council Directive 2004/114/EC of 13 December 2004 on the conditions of admission of third-country nationals for the purposes of studies, pupil exchange, unremunerated training or voluntary service.
- 2) Applicants for the study programme Security Services in Public Administration are subject to additional admissions requirements:
 - a) Succeed in entrance exam and achieve sufficient marks in a written general knowledge test within secondary school curriculum;
 - b) Medical eligibility to studies proved by medical eligibility certificate enclosed in application,
 - c) Payment of €39 for costs related to admissions procedure.
