## **Content of subject:**

- Introduction to criminology. Concept, object, functions of Criminology. Therms criminality, delinquency, negatively social phenomenons, anti-social activities. Criminology and related subjects/subject fields. Acceptation of Criminology for police practise.
- Fenomenology of criminality, Etiology of criminality. Fenomenology: Criminality real, registrated and latent. Real situation, degree, structure and dynamics of development of criminality. Etiology: Relation offender–criminogenic situation victim. Causes (sources) and conditions of criminality. Social, Economic, Political, Law, Cultural and another types of causes and condition of criminality.
- Personality of offender and personality of victim. Therm "offender" psychological, criminology and penal-law definition. Type and typology of offenders. Therm "victim" psychological, criminology and penal-law definition. Therms "victimology", "victimity" and "victimization". Type and typology of victims.
- Prevention of criminality, Youth and criminality. Therms: control of criminality, prevention, represion. Crime prevention according content, addressee and scope. Preventive strategy, preventive project, preventive program, preventive measure. Crime prevention in police practise. Criminality of youthful and delinquency of underage.
