	This scientific paper deals with the importance of foreign language skills for police officers in today's security environment, which is increasingly influenced by globalisation, migration and increased mobility of people between countries. The author points out that language skills are not only a practical tool for dealing with everyday work situations, but also have a broader significance. It is emphasised that foreign language skills help police officers to better apply the principles of the rule of law, prevent and resolve conflicts more effectively, and build trust between the police and the public. The article analyses this issue from two main perspectives. The first is the general social and professional significance of language competence, and the second is the specific possibilities for its use in practice and in the system of professional training for police officers, particularly in the context of the Slovak Republic. The author draws on institutional reports from European police and security authorities and, on this basis, points to the need for the systematic development of language skills within the police force.

[DÉNEŠI, BLANKA (100%)]</p> <p>In her scientific contribution, the author examines the impact of globalisation and multiculturalism on linguistic and cultural processes in modern societies, with Germany, with its high proportion of people with a migrant background, representing a specific case of linguistic hybridisation. She focuses on the role of language in the process of integrating people with a migrant background into German society and the relationship between different language groups, which leads to the creation of new language variants such as Kiezdeutsch. This language originated in multi-ethnic urban communities, where elements of German are combined with languages such as Turkish, Arabic and Russian. The author points out that Kiezdeutsch reflects the dynamics of a multicultural society, but at the same time it is stigmatised and associated with low education and social disadvantage. Language hybridisation can promote social integration, but at the same time it faces challenges in terms of social acceptance and language policy.
