The aim of the international research was to propose a set of rational solutions to increase the effectiveness of detection and, secondarily, punishment of tax crime, based on interdisciplinary conclusions presenting the views of the individual researchers. In the conditions of the growing negative phenomenon in the context of the European Union, as well as the abuse of tax havens, there is a social need for the security forces, i.e. investigators and criminal police, tax and customs authorities, to be ready to respond to the changes that have occurred in several countries, i.e. not only in the Slovak Republic.
