The aim of the article was to point out the need for conceptual, systemic, as well as some substantive changes in civil law regulation in this specific area. The author focused on the focal aspects of proposed adjustments of unjust enrichment in the government proposal for an amendment to the Civil Code published in 2018. Applying comparison, analysis and synthesis, the interpretation of the issue the author focused on the issues of conception and systematic inclusion of the institute in question, as well as on its standardized content. In particular, on the new matters of unjust enrichment, clarification of the existing legal regulation, as well as on the regulation of the issuance of unjust enrichment, while the author emphasizes the protection of good faith, which, as a significant participation of the principle of security and stability in private law relations, is significantly reflected in the regulation of the institute.
