Several researches show that the efficiency and speed of criminal prosecution is a much better preventive measure than the constant increase							

	of criminal rates. The perpetrator is more deterred from committing a criminal activity by the knowledge that he will be sanctioned for his actions than by the severity of a specific sanction. It can be concluded that measuring of the effectiveness of criminal proceedings is important.
